

## REQUEST FOR BOARD ACTION

**SUBJECT:** Adopt a resolution setting the 2016 property tax rate.

**SUMMARY:** The property tax levy for 2016 is required to be set before June 22, 2016.

**FISCAL IMPACT:** For the 2016-2017 fiscal year, the Multiple Service Area Property Tax is projected to be \$10,087.

**STAFF RECOMMENDATION:**

Staff recommends adoption of Resolution No. 16-89 setting the 2016 property tax rate at a rate not to exceed the certified rate to be determined by Salt Lake County.

**BACKGROUND DISCUSSION:**

Utah state law requires the annual property tax levy to be set before June 22 of each year. As of the time of preparation of this document, the District has not received the certified tax information from Salt Lake County. The District traditionally receives the certified tax rate information from Salt Lake County in the June 10-15 timeframe and also traditionally sets its property tax rate at a rate not to exceed the rate that is determined by Salt Lake County.

RESOLUTION NO. 16-89

**A RESOLUTION SETTING THE 2016 PROPERTY TAX RATE**

WHEREAS, state law (Section 10-6-133, Utah State Code) requires the setting of the annual real and personal property tax rate; and

WHEREAS, the District Board has determined the requirements of the fund for which property taxes are to be levied; and

WHEREAS, the property tax rate is not in excess of the tax rate certified by the Salt Lake County Auditor;

NOW, THEREFORE, BE IT RESOLVED BY THE WEST JORDAN FAIRWAY ESTATES SPECIAL SERVICE RECREATION DISTRICT BOARD:

SECTION 1. For purposes of defraying the necessary and proper expenses of the West Jordan Fairway Estates SSRD and for maintaining the administration thereof, it is hereby determined that the rate of the West Jordan Fairway Estates SSRD property tax upon all real and personal property within the West Jordan Fairway Estates SSRD made taxable by law in the year 2016 for the District's fiscal year ending June 30, 2017 is set at a rate of (To Be Determined—not to exceed the certified tax rate to be determined by Salt Lake County).

SECTION 2. The District, by and through the District Board of the West Jordan Fairway Estates SSRD, hereby expressly reserves the power and right to amend the foregoing tax rate as it may deem just, proper, and appropriate under law.

SECTION 3. The City Recorder shall submit a certified copy of this Resolution to the Salt Lake County Auditor on or before June 21, 2016.

SECTION 4. This Resolution shall take effect immediately upon adoption.
