GREEN WASTE
DUMPSTER RESERVATION AND USE AGREEMENT

Our contractor delivers dumpsters 7am - 7pm. We do not have scheduled delivery times.

RESERVATION INFORMATION

- Green waste dumpsters must be placed entirely on private property and cannot impede or obstruct sidewalks or roadways.
Reservations can be made in person or by faxing or emailing this form (info above). You will be contacted to confirm your reservation.
Green waste dumpsters may be scheduled for the same residence as often as necessary (subject to availability). They are often booked up to two months in advance, so please plan accordingly.
Green waste dumpsters may be scheduled year-round for the calendar year. Reservations for the next calendar year will start on the first working day of that year.

RULES AND LIABILITY

To receive the maximum benefit of the City-wide service and to protect public health and welfare the undersigned agrees to abide by the following rules and accepts the terms and conditions as stated:

- Dumpsters are for residential use only and the property must have an open and current West Jordan garbage utility account.
DUMPSTERS SHALL BE USED ONLY FOR YARD DEBRIS. For a load to qualify, the entire load must be green waste.
Toxic, hazardous, or flammable materials (pesticides, herbicides, solvents, chemicals, paints, motor oil, gasoline, etc.), tires, batteries, and concrete are unacceptable items and are not to be deposited in the dumpsters.
Current and future dumpster reservations may be terminated and denied for the resident and property if it is determined that any materials other than green waste have been deposited in the dumpster.
Dumpsters shall not be overloaded. Residents using the dumpsters are required to clean up any spillage from overloading.
The City and the Solid Waste Contractor are hereby released from any and all claims for damages resulting from the City's or the Solid Waste Contractor's equipment or personnel being on private property to deliver or remove the requested dumpsters.
All court costs and attorney's fees incurred in the event of legal action to enforce any term or condition of this agreement will be the responsibility of the undersigned.
