**GREEN WASTE DUMPSTER RESERVATION AND USE AGREEMENT**

**Dumpsters may be delivered *any time* between 7 AM and 7 PM**

**RESERVATION INFORMATION**

- Reservations can be made in person or by faxing or emailing this form (contact info above). You will be contacted to confirm your reservation.
- Green waste dumpsters may be scheduled for the same residence as often as necessary (subject to availability).
- Green waste dumpsters may be scheduled year-round for the calendar year. Reservations for the next calendar year will start on the first working day of that year.
- Dumpsters are generally booked at least one month in advance, so please plan accordingly.
- Green waste dumpsters must be placed entirely on private property and cannot impede or obstruct sidewalks or roadways. The dumpster is approximately 8' x 22' x 5' tall.

**RULES AND LIABILITY**

To receive the maximum benefit of the City-wide service and to protect public health and welfare the undersigned agrees to abide by the following rules and accepts the terms and conditions as stated:

1. Dumpsters are for residential use only and the property must have an open West Jordan Utility account. The dumpsters shall not be used by business or commercial uses of any kind.
2. For a load to qualify as green waste, the entire load must be green waste. **DUMPSTERS SHALL BE USED ONLY FOR YARD DEBRIS.** Green waste consists of yard trimmings and wood products. No railroad ties, telephone poles, treated wood, dirt or sod. **No animal waste of any kind is permitted.**
3. Toxic, hazardous, or flammable materials (pesticides, herbicides, solvents, chemicals, paints, motor oil, gasoline, etc.), tires, batteries, and concrete are unacceptable items and are not to be deposited in the dumpsters. For information on proper disposal of household hazardous wastes, please contact Trans-Jordan Cities Landfill at 801-569-8994.
4. Current and future dumpster reservations may be terminated and denied for the resident and property if it is determined that any materials other than green waste have been deposited in the dumpster. Violators will be invoiced for the City's administrative costs and costs of disposal for any unacceptable items.
5. **Dumpsters shall not be overloaded.** Residents using the dumpsters are required to clean up any spillage from overloading.
6. The City and the Solid Waste Contractor are hereby released from any and all claims for damages resulting from the City's or the Solid Waste Contractor's equipment or personnel being on private property to deliver or remove the requested dumpsters, including but not limited to; any damage to any pavement or subsurface material on any route reasonably necessary to perform the services herein contracted. The City and the Solid Waste Contractor are hereby released from any and all claims for all bodily injury as a result of dumpster use or location of dumpster/s. The undersigned shall be responsible for any and all damage to the dumpster while the dumpster is located on the undersigned's property or while the undersigned is using the dumpster.
7. All court costs and attorney's fees incurred in the event of legal action to enforce any term or condition of this agreement will be the responsibility of the undersigned.
