BACKGROUND DISCUSSION:

Gene Drake was initially appointed to serve as the City's representative on the Board of Trustees of the South Salt Lake Valley Mosquito Abatement District, December 2000. He has served as the City's representative since that time, with his current term expiring December 31, 2016. Therefore, the City Council needs to confirm the appointment of a representative to serve in this capacity for the term of January 1, 2017 through December 31, 2020.

In accordance with Utah State Code 17B-1-304(2)(b)(i), this vacancy has been posted in four public places, as well as published in the Salt Lake Tribune for five consecutive days prior to the deadline for accepting nominees for appointment. The requirements for the position are as follows: 1) Must live within the boundaries of the City of West Jordan; 2) Must be a registered voter, and 3) May not be employed by the Mosquito Abatement District. The City Clerk's Office received only one application requesting appointment to the Board of Trustees: Gene Drake (letter attached).

Whereas, Section 17B-1-304(2)(b)(i), Utah State Code, authorizes the City Council to make an appointment to the Board of Trustees of the South Salt Lake Valley Mosquito Abatement District; and

Whereas, the City Council desires to appoint Gene Drake as a member to the said Board of Trustees of the District,

NOW, THEREFORE, IT IS RESOLVED BY THE CITY COUNCIL OF WEST JORDAN, UTAH:

Section 1. Gene Drake is hereby appointed to serve on the Board of Trustees of the South Salt Lake Valley Mosquito Abatement District, for the four-year term of January 1, 2017 through December 31, 2020.

Section 2. The City Clerk is directed and authorized to forward a certified copy of this Resolution to Gene Drake and to the Chairman of the Board of Trustees of the South Salt Lake Valley Mosquito Abatement District.

Section 3. This Resolution shall take effect immediately.
